● The ANCIENT ORDER refer to this system as the "Gordian Ray", from the Gordian Knot, an ancient, historic knot tied by KING GORDIUS, as seen above. That fact is evidenced in the name of a book they had published in the year 1891. The name of the book is THE PICTURE OF DORIAN GRAY, (GORDIAN RAY).

Gor'di-an knot' /gôrd'ē-an/ n knot tied by Gordius, king of Phrygia, so intricate that an oracle declared that he who loosed it should be master of Asia; cut through with a stroke of the sword by Alexander the Great.

● The year 2000 was approaching. The ANCIENT ORDER tradition is to document history and at the highest levels of government. The ANCIENT ORDER brought about the Impeachment process against President Clinton and placed "Gordian Ray" in the names of the 4 women involved, as seen below:

● As can be seen above, you need all 4 women's names to get the phrase "Gordian Ray". You don't get the "y" (for "ray") until you get to the name Lewinsky and you don't get the "d" (for "Gordian") until Linda Tripp.

● But look at the "G". Only 1 name has a "G", which is the first letter of "Gordian". And the "G" begins the first name, "Gennifer", of the first woman. Gennifer Flowers was the first woman to go on the national news during Clinton's first Presidential campaign to accuse him of extra-marital sex. The name "Jennifer" is always spelled with a "J". But this time, the very first woman's first name, which should be "J", is instead "G". The "G" is because the ANCIENT ORDER were forming "Gordian" from the start.

● The ANCIENT ORDER used these Laser Ray devices to bring about the historic Clinton Impeachment process. Along the way they established federal court legal precedents. They chose the players and marked their names with the ANCIENT ORDER codes. Which woman's lawsuit established legal precedence by pulling a sitting President into court? It was Paula Jones. ● As can be seen, history-maker Paula Jones has the word "one", ONE as in "#1", in her name.

● Only 1 of the 4 women has an "O, G, R & E" in her name. That is the woman who has the "G", Gennifer Flowers. "O-G-R-E" spells "Ogre". As seen here, an ogre is a monster that eats people.
